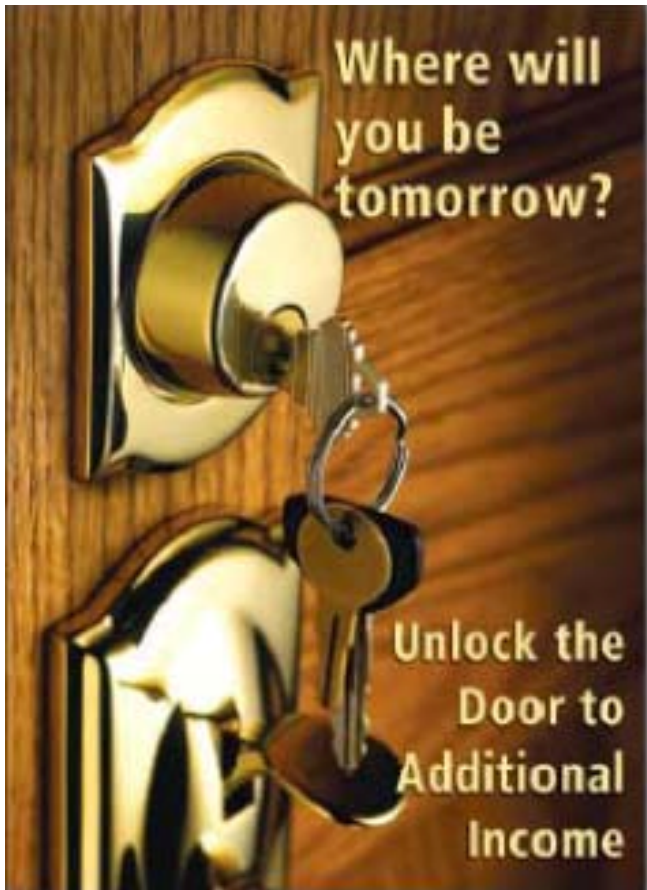


Direct Express



- Any registered representative of TFS may direct a mortgage applicant to our office.
- Our mortgage specialists will work with your client from start to finish – there’s no need for you to handle any of the follow up!

- When the loan closes and funds, you will be compensated as follows:
 - 40% of the Originator’s Compensation
